# *NTA Winter Board Meeting Minuets*

## *Affiliate Network Report*

*Mel Kincheloe, Chairman of the Affiliate Network Committee, gave his report. John Janelli has submitted a letter requesting a by-law change to drop the state affiliation program. Mel advised he has gotten responses for two years except for one letter and one telephone call which were both extremely negative. The Illinois association is not willing to help at this year's convention because of the affiliation. We need to look at the issue closely and decide what to do. R.J. states he sees both sides of the question and thinks members are not happy about the affiliation. Joel Edwards thinks that the program works great in New Mexico but at this point in time it appears the members and industry are very unhappy about it. This will be discussed under new business. Archie Phillips states that he is one of the starters of the affiliation program and still believes in it, but is willing to change it for the good of the membership. Audie Crabtree was recognized and thinks it should be dropped.*

*The Affiliate Network Report was accepted by President Joel Edwards.*

## *Proposed By-Law Change/Affiliation*

*Two separate proposals were sent out to the board with regard to dropping the affiliation program. R.J. Simington's submission would not have been acceptable according to the by-laws and would not have allowed the proposal to be brought to the table. John Janelli sent out a new by-law change request which met the necessary criteria. The proposed by-law change is as follows:*

### *Section 1 Affiliated States*

*The NTA shall make provisions for the affiliation of state taxidermy associations that meet the following requirements:*

*(a) The bylaws of said organization must be in general agreement with the NTA bylaws. Said organization will supply the NTA with a current list of their Officers, Board Members and all members of their organization.*

*(b) Said organization must maintain 100 percent NTA membership within their membership.*

### *Section 2 Affiliated Organizations*

# *NTA Winter Board Meeting Minuets Continued:*

*The NTA shall make provisions for the cross affiliation with other wildlife conservation groups that meet the following requirements:*

*(a) The bylaws of said organizations must be in general agreement with the NTA bylaws.*

*(b) Said organization must strive to promote taxidermy as an educational occupation that seeks to conserve wildlife through the preservation of specimens by using the highest standards in the art. The proposed changes are as follows:*

*Section 1 - Affiliated States, and (a) and (b) of that section, shall be deleted in its entirety.*

*Section 2 – Affiliated Organizations shall be changed to Section 1 – Affiliated Organizations.*

*The new bylaw would read:*

## *Article XIII – Affiliates*

### *Section 1 Affiliated Organizations*

*The NTA shall make provisions for the cross affiliation with other wildlife conservation groups that meet the following requirements:*

*(a) The bylaws of said organizations must be in general agreement with the NTA bylaws.*

*(b) Said organization must strive to promote taxidermy as an educational occupation that seeks to conserve wildlife through the preservation of specimens by using the highest standards in the art. Frankie Thompson read excerpts in a letter from Mike Kirkhart from 2000 in favor of the affiliation. Joel Edwards spoke with Mike Kirkhart yesterday. Mike states the affiliation was a good idea that has created division in the membership. R.J. Simington pointed out that we are board members representing the NTA membership. Tinker Johnson noted the affiliation is dividing state organizations but he is still in favor of it. The 11 states that are 100% need to be advised of the change in a positive manner. Joel Edwards advised that we have thought about it and will do our best to make a smooth transition, if it passes. Archie Phillips suggested it could be put into the Outlook that due to the economic times this is a necessary decision and can be revisited in the future. Steve Wolk asked how much it costs to run the affiliation. Archie Phillips believes it is about \$17,000.00. {00551992.DOC} 16*

*A motion was made by Archie Phillips to accept the by-law change as submitted and to change any applicable rules as necessary; the motion was seconded by R.J. Simington. The motion passed by a vote of 12-2.*


